



PRODUCT WARRANTY – CLASS I, CLASS V-IC & ELECTRIC SIT-DOWN TRUCKS

Hytsu warrants new equipment to be free from defects in materials and workmanship under the conditions of the following provisions.

STANDARD WARRANTY

Hytsu standard warranty for new equipment shall be (12) months or the first 2,000 operating hours after delivery to the initial purchaser, rental or lessee, whichever event shall occur first.

POWER TRAIN PROTECTION WARRANTY

1. Internal combustion equipment
 - a. Engine (excluding all accessories and consumable trade parts)
 - b. Torqflow and standard transmissions (excluding dry clutch and components)
 - c. Torque converter assembly
 - d. Differential and drive axle (excluding brake assembly)
2. Battery-powered equipment
 - a. Electric motors (excluding brushes)
 - b. SCR control panel components (excluding fuses)
 - c. Contractor panels (excluding contact tips and switches)
 - d. Differential and drive axle (excluding brake assembly)

HYSTU OBLIGATION

Hytsu shall have the obligation to repair or replace, at Hytsu's option, any defect in material or workmanship at no charge, by authorized Hytsu dealer, during the specified warranty period.

LIMITATIONS AND EXCLUSIONS

This warranty is not applicable to or inclusive of any of the following:

1. Equipment which has been subjected to alterations and/or modifications not approved in writing from Hytsu, neglect, unauthorized repair, misuse, accidents, lack of reasonable proper maintenance, normal adjustments, improper repairs or replacements, use of parts which do not conform to Hytsu's specifications.
2. Normal replacement of any and all consumable parts such as, but no limited to light bulbs, filter elements, hoses, lubricating and hydraulic oil, and/or parts required to perform a regular maintenance service.
3. Tires and tubes.
4. Batteries for battery powered trucks.
5. Attachments, components, parts or accessories of products or equipment not manufactured by Hytsu.
6. Used products or equipment.

LIMITED LIABILITY

1. Any and all other express, statutory, and implied warranties applicable to product, including, without limitation, all implied warranties of merchantability and fitness for use, are expressly disclaimed.
2. In no event shall the dealer, its customers or users be entailed to recover incidental or consequential damages, including, but not limited to, damages or inconvenience, rental or replacement equipment, loss of profits, or other commercial loss.
3. Hytsu neither assumes nor authorizes any other to assume for it any other liability in connection with the sale or service of the equipment.
4. No modifications, alterations or changes of this limited warranty is permitted or authorized by Hytsu-approved dealer.
5. Some states prohibit exclusion or limitation of implied warranty of merchantability or fitness for a particular purpose, and/or incidental or consequential damages, so you may have additional rights.
